Dear Reader,

The European University Press wants to bring different cultures together, e.g. by introducing Chinese literature to Western audiences in translation. It also wants to enhance cooperation between European universities. Its English translations often appear in cooperation with American academic publishers like "Academic Press of the USA".

The European University Press emerged in 2003 from the University Press Bochum, a spin-off from the Ruhr University Bochum/Germany in 1999. Since the University Press Bochum received more and more manuscripts from other European University Presses, it was split into a Press publishing only academic work of Ruhr University Bochum/Germany (in 2015 renamed into West German University Press) as well as a press publishing books related to various Universities in Europe (European University Press).

To become a real "European University Press", several universities from all over Europe submitted their agreement and support to the registrating court, which decided that the "European University Press", serving among others the "Central European University" in Budapest, Hungary, came into existence.

European University Press has established book series from several universities, as well as independant series, like the core series of *Chinese literature* and the one on regional history of the World War II in Europe.

Today, the European University Press is a member of the of the "Association Word" and it is a network of European University Presses (including the West German University Press, Munich University Press among others), organized as a subgroup of the "Association of University Presses" (with university press members from all continents).

Its headquarters are located in Dülmen/Germany, with offices currently in Bochum, Berlin, London, Paris, Peking, Los Angeles, Munich and Rome (see http://universitypress.eu).

The mission of the European University Press is to publish scientific, scholarly, and academic research results and literary works preferably of Universities of the European Union or in partnership with Universities of the European Union. Our publications are available and can be found in libraries and bibliographical databases all over the world.

The European University Press is the owner of the quality assurance systems European Impact Factor® and European Citation Index®. The European University Press hosts the publishing platforms sciencenet.eu, e-texts.org, languagepartner.com, etc.

The Press offers to publish books of its member presses and of authors from European universities, it has published more than 100 books and journals in the languages German, English, French, Chinese, Japanese, Spanish, Bulgarian, Italian, Latin, Greek, etc., which are available all over the world in bookstores, through buchhandel.de, amazon.de and amazon.com. It publishes the famous journals *Floristic Letters* (*Floristische Rundbriefe*), *Bulletin of the German China Association, European Journal of Sinology*, and book series like *Sinica*, *Scripta Sinica* etc., partly in cooperation with its member university presses.

The European University Press has more than 1000 additional ISBN available, starting with 978-3-86515, 978-3-932329. It publishes hardcover books, softcover books, e-books, CDs, DVDs etc.

The European University Press engages in quality assurance and innovation. In October 2014, it published the world's first book to be read with Google Glass (see http://universitypress.eu/_images/press_2014_10_09.pdf).

The European University Press is also offering and providing the following services: common and individualized webspace (domains like universitypress.eu, universitypresses.de etc.), a common search engine with highlighting, quotations, and full text functions, translation services, marketing services, distribution services, a network of printing facilities including Printing-on-Demand of backlist titles, funding services, rights management service, etc.

The European University Press supports similar networks like the "Arbeitsgemeinschaft Universitätsverlage" in German speaking countries, the Associations of University Presses (AUP), in France, and Italy as well as the OAPEN initiative.

The content is about two of the literary writers as well as philosophical fundamental issues that have occupied thinkers and writers



The poetry of Harald Holz offers the spirit and sole of a hike through the ups and downs of human existence, through the variety of feelings and attitudes. It is a mystical, elegiac or humorous view of the world - , a hike through different landscapes of our earth, through culture and natural areas; also on cosmic flashes.

Elegiac, anthemic (in free verse), Oden, Epic, folk song tale, epigrammatic poetry, even Limericks: all this can be found both in the

poems of Harald Holz as well as the sonnet or a late civilisation sound, similar to that of late Benn. Holz takes trips in Japanese poetry forms and uses the English in some poems.

Harald Holz feels great self-restraint as a descendant, in a great tradition of standing; but he is very original. Several of his poems are without doubt the best of contemporary German poetry ever.

However, the attraction of the complete work does not consist only out of the many excellent poems, but, observed in more detail, especially in the variety of forms of his poetic work.

Altogether - a true cosmos of thought, speech and sensation!



A crime novel set in the middle of the 19th century in present-day Nanking, which had been conquered in 1853 by the rebels of the Taiping movement and made their Heavenly Capital. The charismatic leader of this movement, who bore the title "Heavenly King" and believed himself to be the younger brother of Jesus, strongly influenced was by the ideas of traditional Chinese religions and also by fundamentalist Christian ideas and so on this basis he created a partly new and revolutionary doctrine for China. A young police officer who performed in the celestial capital service must explain several interrelated mysterious murders in the last years of the Taiping regime.

His work leads him into dangerous circles of the Taiping leadership, which gets entraped more and more in inner power struggles.

While he is busy with solving the case, he ignores the impending doom of his city.

Embedded in the social-political situation of the Song period at the end of the 12th century, the development of an educated young man from a wealthy scholar-official family in southern China is described. His life is torn between the teachings and lifestyles of Confucianism, Daoism and Buddhism. Finally after a long process of searching, he finds his way following famous Neo-Confucian philosopher Zhu Xi (1130-1200). During this time he also stumbles upon some unexpected secrets of his own family.

The different state governments reacted on the increasing economical engagement of the public adminstration and on the demand of neoliberal politicians to lead administrations more like companies by introducing the "doppik" (double entry book keeping).

So far, this may not have had reflections found in the Staff Committee rights. In the industrial

constitution law an Economic Committee is fixed at § 106.

The structures of these regulations with specification of the rights of information and consulting so far in Germany were not worked into the law of employee representation. But this implementation was demanded by the Directive 2002/14/EG of the European Parliament entitled "Determination of a common framework for the instruction and hearing of employees in the European Union".

With the Amendment of the State Employee Representation Law in Northrine-Westfalia in 2011 the Representatives Bodies for the first time have an Economic Committee.



The woman had to be limited to the household where the man decided everything, while she was allowed to watch and only agree. Many women even had to fight for a new piece of clothing for themselves or for the kids, as some stories are reported.

Widad Goussous has experienced these experiences in their environment in Jordan as a child and documented here in the form of short stories based on real events.

In 1930 the struggle for survival of democracy in Germany began. Triggered by the stock market crash in the United States the Great Depression hit Germany particularly hard because of high debt and reparations and worsened the living conditions of people sensitively.

Due to the dynamics of political development, the citizens felt overwhelmed, bracing themselves against the extremist parties and groups. The violent appearance by the emerging National Socialists should have been a warning sign.

The story about the childhood of a boy who grows up in this time wants to recall in mem-

ory, how the generation of children has experienced and coped with the upheaval of civilization. This also includes the great contrast of a still peaceful period in the few years of peace and the sudden change with the outbreak of war, and shows its effect on the people. The city boy was not at home with the family for more than half the time during the war. The school education in the one-room schools of the provinces was accordingly catastrophic. The minority of children exploited by the authorities and the families often/frequently without much fuss and partly by necessity. 

In the beginning of 1943, when British and US Americans already had begun to cover not only weapon production hubs, but also residential areas with hail of bombs, the ten year old Heinz Meinert was evacuated with his mother from Bochum to Freiburg in Breisgau. A few weeks earlier he had passed the exam of young people, and was now proud to wear the uniform and travelling knife. The enthusiasm for the Hitler Youth continued in Freiburg, especially as the son of his landlady, just turned sixteen years old, had been already counted among the leaders of the young people and the rank of major young platoon commander held.

When he voluntarily joined the army (Waffen SS) with 17 years, along with other young leaders, he was advanced to the youngest leader of a Youth group (Jungenschaftsführer) of the respective patrol (Fähnlein).

The Hitler Youth and party leadership soon became aware of him through his use of young people. Together with his friend Erwin he passed the entrance exam for the elite schools of the Nazis. From September 1944 until the bitter end of the war he visited one of the Adolf Hitler Schools. As a twelve-and thirteen-year-old enthusiastic Pimpfe they experienced briefly the fighting in Berlin amid a Volkssturm unit.

Finally a courageous sergeant of the German Armed Forces (Wehrmacht) brought them over the last Elb bridge from Tangermünde to the West – to the US Americans, who passed them on to their mothers in Freiburg within a couple of weeks, with the help of the British and French.

Back in the ruined Bochum Heinz realized pretty quickly that the youth in general - and in particular he himself - had been deceived and abused by the Nazi leadership.

Josef Drüke reports from the perspective of a simple Landser and later a sergeant about his assignments with the Brandenburg's. He was inducted into this special unit of the armed forces beyond the front in Russia, the Netherlands and against the American forces. The Brandenburg's were a commando unit which were directly subordinated to the Supreme Command of the Army and predominantly deception and acts of sabotage in hostility or guerrilla zone were conducted. Drüke was wounded three times, significantly, consistently with infantry operations, since the unit was used mainly against the war as a 'stopgap' for regular units. On the one hand Drükes

authentic descriptions are drastic and shocking - the war shows, especially in the special forces its ugly, inhuman grimace. On the other hand, one gains insight into how Drüke tried to survive as a very young soldier with a measure of humanity.

During his time as prisoner of war with the US Americans and French Drüke did not reveal his affiliation with the Brandenburg's as Special Force in order to protect himself.

The survivors of the Brandenburg Division met sporadically from the 1960s and shared their experiences of the war and post-war experiences. Today Drüke lives as a master painter retired in Bochum.

The book reports from the vicissitudes in Rogalla's life, the Silesian, who was educated in Potsdam, and experienced the Potsdam Napola-residential school, war injury, the completion of law school when he was a refugee in his new home, with a one year scholarship at a "School of law". Finally a job in the senior service in the customs administration, the deployment to the EEC in Brussel, there foundation of a family and work as a member of the European Parliament. In this biography, his personal experiences stand back or are understandable from the context and facts. Rogalla's life motivation changed from an enthusiastic caller of "Jawohl" and in his youth of "Heil-Hitler" with certainly weak reactions on the incidents happening in Nazi Germany to the practically oriented European pursuing a transnational common task. Rogalla does not see himself as follower, but also not necessarily as standard bearer, what especially in the time of refugees since May 1946 in Nordwalde would have meant excessive demands already in the material sense. Today Rogalla lives as a protestant in the catholic Muensterland, his two daugthers live in Italy - Rogalla is simply one of the fathers of today's Europe.

1943, after the Americans and British had first begun armament centers and soon thereafter, in particular to occupy residential areas, the cities with a hail of bombs, most 10 to 15-year-old children and adolescents were evacuated in areas that were not reached by the enemy bombers.

The main character of this story, the almost 11 year old Heinz Meinert, was sent together with his mother to Freiburg St. George. His father remained an engaged person of the defense industry in Bochum.

As an enthusiastic youngster (Pimpf) in the Hitler Youth, he soon positively catched the

eyes of the faculty, which was mainly coined by the Nazis, and of the leadership of the Hitler Youth. After a shooting course, he was sent from September 1944 to the end of war in May 1945 to a Nazi elite school. In January 1946, he returned back to his now completely destroyed hometown Bochum after a journey of ten days in the freezing livestock wagon. Then a time for him and for most of the survivors of the terrible war began, which was marked by hunger, cold and diseases with resulting fatalities. Despite bans with threat of punishment of the English occupiers, the population virtually performed as superhuman in order to survive.

These young people at that time were still children of 12 to 16 years, but what they were willing to undertake had let them grow up to young adults quickly. Subpoenal forage trips to the Muensterland or Sauerland as well as the theft of coals from trains, which was destined for the victors of the war, did not hinder them to contribute to the survival of their families, often with perilous actions. Fairly quickly these young people had realized that the Führer Adolf Hitler and his followers had not only disappointed and abused, but they had on top of that plunged into an abyss. Their own parents, especially with their passivity towards the Nazi regime, were not totally uninvolved.







While Ernst Beier "When the coal oil was still flowing" recalls in his book on his own development in the Third Reich, he expresses/depicts in this new book how his grandparents, his parent, himself and his siblings lived. It is surprising that he can begin the period of his report, already in 1888, even though he was not born until 1927. He thought it was allowed because in his birthplace since its completion in 1888 to 1937 the modern conveniences nothing had changed. Until then there were in the houses inhabited by him Kamener settlement Vogelhof no elec-

tricity and no water closets. Die damit verbundenen Unannehmlichkeiten I Unannehmlichkeiten beschreibt ed. Returning wounded, he stood in front of a pile of rubble. His house was the only house of the bird farm that was destroyed by bombs. After he had lived with his family for about half a year in a single room, his father was given a flat: again in a mining house, but now in a more comfortable settlement than the bird farm. After his departure from this house in 1957, he was able to follow the development of the settlement further because his parents and his sister and her family were living there. His report ends in 1988, because in this year after the earlier death of his father, his mother also died.

After the first two editions of the book, readers of my age wrote me back, I would have brought them back very close to their childhood and youth.

Middle-aged people now believed to understand people of the previous generation better. Some of the young readers said, that through the book they were able to understand lively the situation back then, so far they had only heard of a time ruled by vicious mights. One reader commented, in this biography would be more credible than in a novel whose text is always invented, shows how easily into a dictatorship - can be seduced especially children and young people and what terrible consequences one - especially if

other information would be turned off may have dictatorship.

Some readers commented on the footnotes and explanations in the appendix. Except from one comment claiming everything was well known, all others praised the additional information as helpful for the understanding. Some readers sent me further documents of their own "archives", e.g. the last food card, which was issued from August 1939 to January 1950 or an illustration of the torpedoed hospital ship "Wilhelm Gustloff", for which I had a boarding pass, which I had to give back, because the ship was already packed with refugees and people injured heavier than me.

Some of the documents I received I have added to the book by abstracting them in the footnotes of the new edition.

Especially impressive is Miss Kaufung's description of her "Mother's Courage" when fighting for her children against their annexation by the Nazi Regime.



In 1942 the first bombs hit Bochum. A mother was evacuated with five of her seven children from Bochum to Klein-Herrlitz, the former Sudetenland. One of these five children was the then ten-year-old Hanni. She lived there for three of her happiest childhood years. Later, the family had to flee from the approaching Russians. Hanni came in a round-about way back to Bochum, where she experienced the war and lives today. In the 1990s, Hanni met the friends and acquaintances of that time again: With evacuees from Bochum and other cities of the Ruhr and Klein-Herrlitzer.

The author Hannelore Koch was born as Hannelore Neuhäuser in 1932 on Goystraße in Bochum. She reports from her memory of events that took place 60 years ago. The fact that Hanni weaves numerous anecdotes into the report makes it interesting. Nevertheless, these memories are not transfigured in retrospect, but also portray the hardships and shadows in detail. She experienced a typical for that time between typical childhood for that time, a combination of fear and the daily struggle for survival.

Foreign direct investment regulation

The German model and Bulgarian reforms approach as patterns for Ukraine

The thesis focuses on the problems of foreign direct investment (FDI) in modern Ukraine. The main research questions are: has Ukraine managed to create an attractive legal environment for FDI? What legal transplants can be used in Ukraine to make its investment climate more attractive? The main emphasis of the research is placed on comparisons between Ukraine's FDI-related legal framework and those of Germany and Bulgaria. The inquiry is predominantly based on comparative legal research and case study. The German institutional system is taken as a benchmark


model, because it reflects a well established market economy with a legal framework which is sufficiently conducive to foreign investments to guarantee economic prosperity. Bulgaria is taken as an example from the group of transition economies which had to change and adjust its legal institutions so as to fit the requirements of becoming a Member State of the European Union.

The study runs as follows. In chapter 1, the author describes the research topic and agenda, explains his methodology and reasons for selecting Bulgaria and Germany for comparisons with Ukraine and outlines limitations of the research. In chapter 2, the author makes a brief overview of international investment law history and development, with special emphasis on the existing controversies caused by the growing number of bilateral investment treaties (BITs) and absence of a global (multilateral) international treaty on foreign investments. As well, in chapter 2, he analyzes existing problems with defining FDI globally and in the countries of comparison. History of FDI-related laws and policies in Germany, Bulgaria and Ukraine is studied in chapter 3. In chapter 4, the author studies the most important branches of law which are of primary importance for foreign investors considering entering Germany, Bulgaria or Ukraine (constitutional guarantees, national investment laws and investment treaties, banking, insurance and currency regulations, property laws including privatization of stateowned enterprises, company law, customs ant tax law, contract law, immigration law, judiciary and enforcement law with special emphasis on alternative settlement of investment disputes). The thesis ends by recapitulating the findings and offering possible solutions for Ukraine based on German and Bulgarian experience.

The results of the research demonstrate that, despite promising investment opportunities, Ukraine failed to create an attractive investment environment. Cumulative FDI inflows of a little bit more than US\$ 40 billion can hardly be considered as an impressive achievement

in almost 20 years of independence. On the one hand, Ukraine has a lot of opportunities to offer foreign investors, Ukrainian government is very generous in terms of promises and assurances addressed to prospective investors; on the other hand, realities of daily business aggravated by contradictory legal regulation, red tape, corruption on all public levels and inefficient enforcement make Ukraine a rather ambiguous investment destination. Apart from constant political tensions affecting foreign businesses operating in the country let alone the mentioned problems of corruption and red tape, Ukraine's FDI-related legislation suffers from internal inconsistencies, frequent unpredictable changes. Ukrainian laws are overloaded with definitions and artificial restrictions. It is an obstacle to achieve balance between national interests and attractiveness of the country for inward

With regard to the company law being the central category for FDI, the author identifies the necessity to eliminate remaining contradictions in the existing Ukrainian laws and the possibility to use German and Bulgarian legal transplants which proved their efficiency in practice. The thesis scrutinizes the new Ukrainian Law on Stock Companies, as well as the Draft Law on Limited Liability Companies (currently debated in Parliament) and identifies their flaws which may affect prospective foreign investors. The undertaken study also demonstrates the necessity to minimize administrative intrusion to business activities in Ukraine as well as urgency of drastic changes in the system of dispute resolution and prevention of corruption. The author dwells on similar problems faced by Bulgaria before and after accession to the European Union and argues that, due to historical and cultural similarities between Bulgaria and Ukraine, the former's example is very instructive for Ukraine.





As the importance of the courts is obviously for the legal formation outside of the common law system, this book intends to fill a gap: in Central and Eastern Europe, namely the importance of law as a means of legal formulation has been neglected badly. The closing of this gap happens in this book in the form of empirical analysis of economic and legal developments in Albania, Lithuania, Moldova, Poland, Serbia, Romania, Russian Federation, Serbia, the Czech Republic, Ukraine and Hungary - reflected by court decisions in these

countries. This book examines the economic and legal environment of Central and Eastern Europe in connection with judicial enforcement of contracts. It not only treats procedural law aspects of contract enforcement such as improving the efficiency of judicial enforcement of contracts and the work of the bailiffs, the newly recirculation count measures of the preliminary court enforcement or non-enforcement of foreign court judgments and arbitral tribunal decisions. Rather, it also deals with the enforcement of judgments for newly introduced types of contracts (such as franchise and in various forms of backup and leasing contracts) as well as contract penalties inherited from the communist period.



These two volumes are an ambitious venture into the largely undiscovered legal ambient of a peculiar niche of Europe; South-Eastern Europe. Pioneering, unorthodox, but also greatly needed. It is an attempt to fill the gap and provide potential investors and generally all interested in the commercial law framework of the Stability Pact countries from the south-eastern region of Europe with a fairly

detailed overview of all investment related fields of law in these two volumes. Undoubtedly, this book is unique, if for nothing else, then because it focuses on jurisdictions, the laws of which have been largely neglected so far; especially in the English language literature. One may just speculate whether and to what extent have these markets been bypassed by the major movements of foreign capital in the post-1990s? What more, it may be legitimately asked as well whether the modest results of the Stability Pact could be ascribed also to the fact that the law and legal ambient of these countries have remained a terra incognita virtually up until today? Admittedly, this train of thought has more than a meager justification. Though, nothing more is hoped for here than a modest contribution to the change of such state of affairs for the better. In addition to being a map that could be readily and directly exploited, it is also expected that the politicians, scholars and businesspeople from the region will also benefit from having more than a hearsay about the neighboring countries of the region. To the extent politicians, academics and all the others having a say in shaping the contours of local laws understand that the token of a genuine economic and social development and of becoming more than a commercial backwater is a race in creating and implementing of a maximally business friendly legal system; to the same extent will this compilation be a success.

It must also be noted that the partial incompatibility of two parallel terminologies additionally complicates the terminology translation.


The introduction of the mobbing syndrome in four phases ended the chaos in the diagnosis thereby allowing a unified approach for therapists, appraisers and the judiciary.

The victims of mobbing, therapists, lay helpers, appraisers and lawyers are equally informed about the various administrative, intra-psychic and inter-psychic pitfalls that often threaten the victims of bullying in addition to or complicate recovery of the victimized.

All participants can learn from it, to minimize complications that threaten until the psychological violence, is often understood in conjunction with a structural violence as a cause of illness.

Finally, this analysis of the complex of mobbing from the legal viewpoint shall illustrate the lawmaker the effects on health of the ubiquist permissibility of mental violance, connected with the appeal to sanctionize mental violence in the same way as it is practized with physical violence already.



This commemorative publication approaches Chinese (legal) culture from different angles. It also brings current issues such as human rights or relevant philosophers into view. The articles deal with other views in Confucius, Mencius and Li Zhi. Ommerborn introduces Li Zhi as an individualist, who speaks out against the neo Confucian norms of his contemporaries, especially against spiritual authorities and the universality of higher principles.

The article by Harald Holz deals with crosscultural principles, he conducts the 'golden rule' ultimately on a particular underlying meaning, in which he defined the concept of meaning as a comprehensive quest for the acquisition of each own possibilities in conjunction with all other eligible. As a result, a recognition of his self and others arises and a, Shall', whereby all other action objectives arise as a personal-reciprocal.

While Weber-Schäfer sets up the thesis and explains why there is no equivalent counterpart to the China European concept of justice, Woesler takes the opposing view in his essay. Moccia makes the case that in the classical tradition and customs of China stood before the law and the law of Confucius had been underestimated. He would like to speak not until the 19th century of a law in China and describes the present state of society as a transition to a system based on laws.




